**VI. COMMISSIONERS OATH OF OFFICE** - Chair Elkins and Kelly Henson welcomed our three new Commissioners (listed below) and swore them in.

*Sheryl E. Stalvey*-Stalvey teaches sixth grade reading at Willie J. Williams Middle School. She earned County Teacher of the Year in two Georgia counties. She published an article in the Journal of At Risk Issues and served on the English Language Arts Advisory Committee with the Georgia Department of Education. *D. Scott Justus*-Justus is currently the assistant principal and athletics director at West Hall High School.
